At this time, we are currently seeing a large uptick in fraudulent websites, especially coming from Facebook. We have had multiple residents being told that they have a virus after clicking on an ad on Facebook. These sites lead you to the scammers who will attempt to get personal information, as well as your bank account information.

There were many fraudulent "Black Friday" sites which purported to have huge savings from major name brands. If it seems too good to be true, it usually is.

As we near the Holidays, Porch Pirates and mail thefts will be on the rise. Please pay special attention to mail and packages being delivered to your home. Do NOT leave them out for any extended periods of time.

## HIGHWAY DEPARTMENT

**Reminder: The town has enacted a winter parking ban effective November 15 through April 15, each year. This ban prohibits parking in or on the Town's roads or rights-of-way. The Town has the right to tow or ticket violators. The purpose of this ban is to allow winter maintenance crews unobstructed snow removal and ice control routes and, as much as possible, to maintain the maximum effectiveness of their efforts.**

**All cars found abandoned in the traveled portion of roads within the Town of Chesterfield between November 15<sup>th</sup> and April 15<sup>th</sup> hampering highway operations will be towed at the owner's expense.**

**Please be advised that there is no winter maintenance on the North Hinsdale Road between the Towns of Chesterfield and Hinsdale; this portion of the road has been closed for the winter months.**

**As per Town policy, the Town of Chesterfield plow truck drivers are not obligated to plow to mailboxes. However, the Town holds no financial responsibility for anything placed within Town right-of-ways that may be damaged by snow removal or normal road maintenance.**

**Sand Piles will continue to be located on Cady Lane, Pond Brook Road, Chamberlain Way and the intersection of Route 63 and Stage Road.**

#### CONSERVATION COMMISSION NEWS

As you wander into the woods and forests, many of the forest floor plants continue to provide beautiful greenery throughout the season. I'm particularly fond of some the combinations you will find when you wander along the trails. I've provided a picture of partridge berry and wintergreen accompanied by one of the true mosses. As you start to take notice of certain plants, you will begin to see how, when finding one, you will find often find a companion plant close by, thanks to similar habitat characteristics. Another aspect of the small native plants is their vulnerability to constant compaction. When walking along a trail, you can easily see the compacted dirt bordered on both sides by the forest floor plants. Once the ground becomes well traveled, the plants can no longer grow, hence the

saying, “following the beaten path”. So keeping to the designated trails will help keep the forest floor flourishing, providing for a more diverse and healthy forest. Get out and enjoy the trails we are so fortunate have available to us!
