### **Board of Selectmen Notes February 2024**

#### **Community Power**

There will be a meeting at the Town Hall this Thursday, February 1st at 6:30 pm to discuss Chesterfield joining the Cheshire County Community Power Plan. Representatives from the County will be hand to answer questions.

#### **Town Elections**

This Friday, February 2nd is the last day to fill out a declaration of candidacy for town elected officials. The Town Clerk will be open from 3 to 5 pm on that day to receive last minute declarations.

#### **Meet the Candidates**

Town Elections are coming up on March 12, 2024. Your chance to "Meet the Candidates" will be at the Town Hall on February 25 at 4PM. All candidates for Town office will be invited to attend and this will be your chance to meet them and ask questions. There will also be discussion on proposed changes to the Zoning and Building Ordinances which will also be on the ballot in March.

#### **Watershed Committee**

The Watershed Committee has been working with the Planning Board on Town Ordinance changes to help protect the Lake Spofford Watershed. These proposed changes will be on the ballot at the Town Election on March 12, 2024. We are starting to see the winter weather and coupled with that are the various road conditions. By far, the majority of cars who are in accidents or driving off the road during inclement weather is improper tires. Please don't take the chance of hurting yourself or someone else, put on winter tires (studded tires are great too). You will be glad that you did.

I am receiving complaints of numerous cars being parked in the roadway at bus stops. I have been told that to get around these parents, you have to "weave back and forth." We all want to ensure that our children get on the bus safely. If you are unable to carpool your children to the bus stop, or don't have any areas that can

keep your care completely off the road, then speak with the other parents... Utilize one side of the road, check with neighbors to see if you can park in their driveways. We want to make sure our children are safe, but we also want to be considerate of the rest of the motoring public.

## HIGHWAY DEPARTMENT

Update -- Mud season has been known to appear in February so be prepared. Also please do not leave any vehicles unattended in the road during a snow storm.

**Reminder: The town has enacted a winter parking ban effective November 15 through April 15, each year. This ban prohibits parking in or on the Town's roads or rights-of-way. The Town has the right to tow or ticket violators.**

**The purpose of this ban is to allow winter maintenance crews unobstructed snow removal and ice control routes and, as much as possible, to maintain the maximum effectiveness of their efforts.**

**All cars found abandoned in the traveled portion of roads within the Town of Chesterfield between November 15<sup>th</sup> and April 15<sup>th</sup> hampering highway operations will be towed at the owner's expense.**

**Please be advised that there is no winter maintenance on the North Hinsdale Road between the Towns of Chesterfield and Hinsdale; this portion of the road has been closed for the winter months.**

**As per Town policy, the Town of Chesterfield plow truck drivers are not obligated to plow to mailboxes. However, the Town holds no financial responsibility for anything placed within Town right-of-ways that may be damaged by snow removal or normal road maintenance.**

**Sand Piles will continue to be located on Cady Lane, Pond Brook Road, Chamberlain Way and the intersection of Route 63 and Stage Road.**



The Town of Chesterfield is now able to issue portable Transfer Station permits to property owners of short-term rentals for their renters. These permits will be affixed to plastic to be hung on a vehicle's rear view mirror. To apply for a permit, please see a Transfer Station attendant or the Town Administrator for an application. In addition to being aesthetically beautiful, these images also contain a staggering amount of scientific data that is a vital means to better understand our universe. Using astrophotos created by high school students at the nearby Perkin Observatory, you will learn how these images are acquired by telescopes, processed by computer software, and what can be learned from them. Along the way we will tour the cosmos from the birth and death of solar systems to the evolution of distant galaxies with stops at clouds of ionized gas and the search for extrasolar planets along the way.
