HIGHWAY DEPARTMENT

Reminder: The town has enacted a winter parking ban effective November 15 through April 15, each year. This ban prohibits parking in or on the Town's roads or rightsof-way. The Town has the right to tow or ticket violators. The purpose of this ban is to allow winter maintenance crews unobstructed snow removal and ice control routes and, as much as possible, to maintain the maximum effectiveness of their efforts.

All cars found abandoned in the traveled portion of roads within the Town of Chesterfield between November

15th and April 15th hampering highway operations will be towed at the owner's expense.

Please be advised that there is no winter maintenance on the North Hinsdale Road between the Towns of Chesterfield and Hinsdale; this portion of the road has been closed for the winter months.

As per Town policy, the Town of Chesterfield plow truck drivers are not obligated to plow to mailboxes. However, the Town holds no financial responsibility for anything placed within Town right-of-ways that may be damaged by snow removal or normal road maintenance.

Sand Piles will continue to be located on Cady Lane, Pond Brook Road, Chamberlain Way and the intersection of Route 63 and Stage Road.



The Town of Chesterfield is now able to issue portable Transfer Station permits to property owners of short-term rentals for their renters. These permits will be affixed to plastic to be hung on a vehicle's rear view mirror. To apply for a permit, please see a Transfer Station attendant or the Town Administrator for an application. CONSERVATION COMMISSION NEWS

As you wander through the forest, you can find groupings of the small evergreens known as clubmoss. Keep your eyes peeled when in a more moist environment. Different varieties can be found together but often are more likely in singular groupings, perhaps due to their rhizomes or runners that connect them. The photos show princess or ground pine, bristly pine and ground or creeping cedar. Due to the rhizomes, folks would pull up strands for Christmas decorations, which is discouraged as they are slow growing plants. The plants evolved over 400 million years ago as one of the earliest vascular plants, meaning they can conduct their own food and water. Intriguingly, fossil records from 300 million years ago show clubmoss once reached heights of 100 feet. At the end of the Paleozoic period all tree forms disappeared but it is speculated that the clubmoss came back in its pint-sized version allowing for a greater chance of survival due to its self-contained watering system and a bitter taste that discouraged foragers. A true wonder of evolutionary adaptation!
