

CHESTERFIELD CONSERVATION COMMISSION NEWS

A number of us may be noticing a series of dirt mounds spreading across our yards. It is a little early, but the critters responsible are moles, either the star-nosed, which is essentially blind, or the hairy tailed mole, both native to North America. Both are about 5 inches long and are covered in short, gray fur. In their search for grubs, snails, worms and termites along with other insects and invertebrates, they can create tunnels 30 feet long connecting them to as many as 15 other tunnels. And this is all done by one mole as they are solitary, nocturnal creatures.

Though the dirt piles can become unsightly, the moles tend to move on after a couple of weeks. In the mean time, controlling the grubs, who are one of the culprits feeding on the roots of grass and other plants, can help discourage mole activity, using environmentally friendly products. One can also try castor

oil as a mole deterrent. You can also benefit the lawn by spreading the dirt across the lawn. And moles are natural aerators, moving air and water more freely through the soil so their brief stay might not be so problematic after all.
