Review of the Minutes

February 1, 2021

Joe Brodbine moved to approve the minutes from February 1, 2021 as amended. The motion was seconded by Roland Vollbehr and passed unanimously by roll call vote.

Items for Discussion (7:00)

Blake Amacker - Conceptual consultation - Lyman Way

Corliss noted that minutes are not taken and the discussion is non-binding on the applicant or the board.

Voluntary Merger – Kenison

Parisi asked what the Planning Board role is for a voluntary merger. Corliss noted that if the board knew something about the property, they could bring it up. Parisi asked if the lot had enough frontage. Corliss noted that the frontage is 792 and 329 noting that there is enough frontage. Koopmann asked if there are pins properly set on the property. Corliss noted that there are no new lots being created. McKeon noted that the interior lines are disappearing and there are no other changes to the lot. Koopmann asked if this was an opportunity to have them done properly. Parisi asked if it was not a requirement at the time the lots were created, if it was appropriate to require it now. McKeon noted that there are no new boundary lines and therefore the board could not require those changes.

Roland Vollbehr moved to approve the Kenison Voluntary Merger as presented. The motion was seconded by Joe Brodbine and passed unanimously by roll call vote.

Items for Information

Brodbine noted that the Steep Slope ordinance has been getting a lot of attention. Corliss noted that he attended the public forum last Saturday. Corliss stated that he presented the history but did not take a position and noted that nobody was authorized to speak on behalf of the full board. Parisi noted that there is a meet the candidates scheduled for the 6th, but he has been unable to locate any zoom information. Shippee noted that it has been moved to March 7th and the information has not been posted yet on zoom. Corliss noted that he asked Parisi to attend in the event there are Planning Board questions. Parisi noted he would like a schedule to know how long it is anticipated to take. It was noted that the only contested spots are Budget Committee. It was stated there are 3 open positions and 5 candidates.

Corliss noted that the Orange Door Design/Cormier application was continued to March 15th.
