TRANSPORTATION SUBCOMMITTEE - PLANNING BOARD

Friday, July 8, 2022

Public meeting convenes at 7:00 p.m.

Call to Order: Maria Bissell called the meeting to order at 7:00 pm.

Review of the Minutes

No previous minutes to review

Items for Discussion

Provide information on potential needs of town to submit to SWRPC in response to ask of town of Chesterfield, NH for input on 9 West corridor

James Hancock opened the discussion with the reminder of likely future increasing volume of residents in Keene, NH, which will likely lead to an increased volume of traffic going both east and west on Rte. 9. Group was all in agreement that there is a need to look towards quicker East/West route for future NH growth and commerce.

Subcommittee discussed how we would like to address our town's/state's needs. Decision was made to focus on larger goal (#1 below), medium goal (#2 below), and short-term goals to alleviate existing traffic on Rte. 9 West (#3 below).

- 1. Primary/dedicated East/West highway incrementally developed starting at the Daniel Webster to Keene with additional phases to extend to I-91.
 - *Subcommittee believes this will lead to benefits in additional opportunities for increased housing, workforce, reduced traffic through cities and towns, potential increase in tourism, safety, and lowered commute times with dedicated highway.
- 2. Current East/West routes from 9, 101, and 12 East of Keene look at more opportunities to increase passing lanes prior to and following towns.
- 3. Requests specific to Rte. 9 West through Chesterfield, NH to alleviate issues with existing traffic.
 - a. Look for more opportunities for increased and safer passing lanes.
 - b. Longer and additional turn/merge lanes in Stow Drive area to accommodate large trucks. Make Poocham Rd. entrance onto Rte. 9 right turn only (signage to be added 'No left turn').
 - c. Improve sight lines from Stage Rd.
 - d. Look for additional turn/merge lanes at higher traffic businesses and roads coming onto and off Rte. 9 West (examples Chesterfield Gorge, Big Deal, and Glebe Rd).
 - e. Extend passing lanes past the crest of hills (example Chesterfield Hill).
