# **Review of the Minutes**

John Koopmann moved to approve the minutes from the August 3, 2020 meeting as amended. The motion was seconded by Joe Brodbine and passed by majority with one abstention (Parisi).

## Appointments

**Errold & Tina Nelson -** Application for a Boundary Line Adjustment for property located at Margo Ave (Map 7, Lot E20-2 and Map 7, Lot E20-3) consisting of approximately 10 acres in the Residential Zone.

Jeanny Aldrich moved that the Boundary Line Adjustment application for Errold & Tina Nelson is complete enough for review. The motion was seconded by Joe Brodbine and passed by majority with one abstention. (Parisi)

It was noted the board noted that there were no setbacks on the previous plan and the plan was not signed by the surveyor.

The board received updated plans. It was noted that a revision date was not included on the updated plans.

Wendy Pelletier from Cardinal Surveying was present for the applicants. Pelletier noted that the Nelsons own three (3) lots at the end of Margo Ave and they would like to move the boundary line as shown on the plan to create more equal lots. Pelletier noted that the road frontage will not change.
